## Summer Fellow with COR Expeditions

**ACCOMMODATIONS:** Lodging will be in cabins equipped with beds, linens, towels, bathrooms and showers. Cabins can vary in size and furniture. All lodging are on a first come first serve basis.

MEALS: breakfast, lunch and dinner. Travel days (1st and last day) 1-2 meals will be provided.

**ACTIVITIES:** A University representative will accompany the group for the entire week. You will have an opportunity to do horseback riding, rock climbing, rappelling, hiking, canoeing and fishing.

**TRANSPORATION:** Transportation is provided to and from the Salt Lake City airport (SLC). If you chose not fly into this airport, you will be responsible for making your own arrangements to the Salt Lake City airport at the requested time.

**NOT INCLUDED:** 1) Airfare, airport fees, departure taxes, and fuel surcharges and 2) meals not included in the itinerary, sightseeing or services other than those specifically mentioned, items of a personal nature, laundry materials.

**DEPOSITS:** A deposit of \$400 per person is required to secure reservations. The balance is to be paid in full no later than June 6, 2020. Payment of final balance after this due date will incur a \$50.00 late fee.

## **CANCELLATION AND CHANGES**

In the event of cancellation, your request must be in writing. The following cancellation schedule is based on per person:

- All registration cancellations will result in a \$100 processing fee per person.
- Additionally, 45 Days prior to departure there is an additional cancellation fee of \$500 fee per person (After June 3, 2020)
- 14 Days prior to departure: No refund (After July 4, 2020)

## Additional Change/Cancellation Fee Information:

When we assist in arrangements outside of the normal pilgrimage package and minimum work is required, this will be done at no charge. If however, changes are made outside the pilgrimage package such as cancellations or any other changes then a nominal change fee of \$50 will be imposed by Franciscan University Pilgrimages Dept. This does NOT include any cancellation fees charged by 3rd party affiliates.

**INSURANCE:** Travel insurance is **NOT** included in the tour price. Because of the cost of medical care outside the United States, the fact that Medicare does not provide coverage outside the United States, the possibility that your own insurance provider may not cover you outside the United States, and due to the potentially high cost of escorted air evacuation, travel insurance is recommended. Check with your current insurance company or AAA for travel insurance options.

**RESPONSIBILITY AND LIABILITY:** For all land arrangements including surface transportation: Franciscan University and the participating COR Operators operating the land tours act only as agents of the bus operators, sightseeing contractors and others that provide the actual land arrangements and are not liable for any act, omission, delay, injury, loss, damage or nonperformance occurring in connection with these land arrangements. Any carriers and other transportation companies whose services are used to get to or used for this pilgrimage are not to be held responsible for any act, omission or event during the time passengers are not on board their conveyance. The passage contract in use by COR when issued shall constitute the sole contract between the companies and the purchaser of these tours and/or passage.
